

"Ask the Expert" - a new way to ask your questions or express concerns:

In response to the government health recommendations regarding COVID-19, we have cancelled our monthly group support meetings. We want to "keep the conversation going" and would like to hear any questions or concerns you have regarding epilepsy. These can be questions about yourself, a loved one, friend, family member, neighbor, etc. We will gather questions and respond to them in upcoming newsletters. All questions posted will remain anonymous and we will "ask the expert" to respond to your question or concern.

Listed below is a question we received this month.

"What exactly is a seizure?"

A seizure is a sudden surge of electrical activity in the brain.

A seizure usually affects how a person appears or acts for a short time.

Many different things can occur during a seizure.

Seizures can take on many different forms, and seizures affect different people in different ways. Anything that the brain does normally can also occur during a seizure when the brain is activated by seizure discharges. Some people call this activity "electrical storms" in the brain.

Seizures have a beginning, middle, and end. Not all parts of a seizure may be visible or easy to separate from each other. Every person with seizures will not have every stage or symptom described below. The symptoms during a seizure usually are stereotypic (occur the same way or similar each time), episodic (come and go), and may be unpredictable.

Things to know:

- Seizures can take on many different forms, and seizures affect different people in different ways.
- Not all parts of a seizure may be visible or easy to separate from each other. Every person with seizures will not have every stage or symptom.
- An aura or warning is the first symptom of a seizure and is considered part of the seizure. Not everyone has an aura.
- The middle of a seizure is often called the **ictal phase**. This correlates with the electrical seizure activity in the brain.

 As the seizure ends, the **postictal phase** occurs - this is the recovery period after the seizure. Some people recover immediately while others may take minutes to hours to feel like their usual self.

New Consumer Protections Against Surprise Medical Billing

In December of 2020, Congress passed the No Surprises Act (NSA) which bans the practice of "surprise medical billing" and creates new consumer protections.

The Epilepsy Foundation and many other patient advocacy organizations supported this legislation and have been commenting to facilitate its implementation. Surprise medical billing occurs when an individual receives a bill because they saw an out-of-network provider. This usually occurs in two primary circumstances: emergency rooms or planned care. In emergency situations, particularly if people have been transported by ambulance, people may receive care in an out-of-network emergency room. For scheduled medical appointments, services and procedures, people may plan to receive care at an in-network facility but are treated, without their knowledge, by an out-of-network provider. Under either circumstance, because the provider is out-of-network, the insurer either won't pay them or won't pay their full charges. The patient is then billed for the remainder, which can be tens or hundreds of thousands of dollars. This practice is also known as "balance billing."

The new law addresses these two scenarios differently. In emergency situations, surprise billing or balance billing is banned. The patient should not receive, and is not required to pay, a bill (other than their regular cost sharing amount) for seeking emergency services in an out-of-network ER. If a person comes to an out-of-network ER and needs to be admitted, the hospital must provide notice that they are out-of-network and assist the patient to find an in-network hospital and facilitate transportation. The hospital cannot do this until the patient is stabilized. If a person is seeking planned care, the facility must notify them if the facility or one of their providers is out-of-network. If the patient still wants to seek care, they must sign their consent to be billed.

For uninsured patients, the facility is required to provide a "good faith estimate" of the charges. For insured patients, facilities are not yet required to provide a "good faith estimate" of the charges but they will be in the future.

These new consumer protections took effect January 1, 2022.

For people with epilepsy, it is important to know your rights.
